RENTAL AGREEMENT AND POLICIES

I hereby acknowledge and agree to the following rental agreement terms and conditions:

I _____ Scooter / Bikes are rented out clean and in proper working condition and must be returned in the same manner. I _____ Helmets are included in the rental, and are required to be worn at all times while riding bikes / scooter rented from 2WheelTrip Bikes / Scooter Rentals. If a customer is seen riding the rental bike/scooter without a helmet, they will immediately have to return the bicycle with no refund. Our Bikes / Scooter are maintained on a daily basis. It is the responsibility of the client to check the bike at the pickup location BEFORE setting out on any ride. Customer agrees to return the bike in clean, UNDAMAGED condition to avoid any ADDITIONAL charges for repair, maintenance or replacement. Customer accepts use of the equipment, AS IS, in good condition and accepts full responsibility for care of the equipment while under his/her possession. Damaged parts or components will be repaired / replaced at the shop's discretion and customer agrees to pay regular shop rates and retail prices for components replaced. Clean condition means normal wear and tear is accepted but does not include broken parts, rims, bent rims, damaged frames, handlebars, seats or other parts from misuse and/or crashes. Note: All bikes should be returned clean of mud and debris. Daily rentals are due back 15 minutes before closing time. Late returns are subject to fees. Customer agrees to provide **2WheelTrip BIKES & RENTALS** with credit card details, for precautionary use only: In case of theft, I will be responsible for reimbursing 2WheelTrip Bikes / Scooter Rentals for the original price of the bike/ scooter, plus the cost of any accessories that were provided at the time of the bike rental.

1. **User documentation:** Valid driving license to ride a motor-cycle with/without gear, depending on the Vehicle proposed to be hired. Valid ID proof (**Original**) has to be deposited and will be returned at the time of returning the bike / scooter.
2. **Booking, payments and cancellation:** Early return will not be refunded.
3. **Pickup and return of the vehicle:** Bike scooter has to be returned on time if there is any delay will be charged extra.

4. **Use of vehicle and conduct:** The user agrees and acknowledges that 2WheelTrip Riders prohibit the use of the Vehicle in the proper manner following are the rules of RTO.
5. **Accident and Breakdowns we have the best vehicle if any given situation if the vehicle breaks down will take time to arrange the different bike.**
6. **In the case of any damage or loss to vehicle provided client is full responsible for reimbursement.**
7. **Late returns will be charged: Rs 100/- per hour.**
8. **DRINK AND DRIVE POLICY & GOVERNING LAW has to be followed all times.**
9. **CROSSING BORDER: Vehicle provided is only for tourist they visit local tourist attractions not for any commercial purpose.**
10. **Security Deposit: Rs.1000/- has be paid per bike / scooter which will be refunded at the time of returning the vehicle.**
