- 2. In the event of online submission, both technical Bid (Part-1) and Financial Bid (Part-II) should be submitted concurrently duly digitally signed in the Website https://wbtenders.gov.in
- 3. Eligibility criteria for participation in tender:
- i) The intending tenderer should have credentials of
 - a) A similar nature of work of the minimum value of 40% of the estimated amount put to tender during 5 (five) years prior to the date of issue of this tender notice.

b) 2 (two) similar nature of work, each of the minimum value of 30% of the estimated amount put to tender during 5 (five) years prior to the date of issue of this tender notice.

- c) One single running work of similar nature which has been completed to the extent of 80% or more and value of which is not less than the desired value at (a) above.
 - In case of running works, only those tenderers who will submit the certificate of satisfactory running work from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender. In the required certificate it should be clearly stated that the work is in progress

- satisfactory and also that no penal action has been initiated against the executed agency, i.e., the tenderer. (Please fill, sign and submit Annexure-II).
- ii) The intending tenderer will have to produce the following information / data / credentials / certificates etc. to the undersigned along with the prayer for obtaining permission to participate in the tender (**Please fill, sign and submit Annexure-I**):

The documents as mentioned above will be examined in order to assess the eligibility of the applicant to participate in the tender. On being satisfied about the eligibility, necessary permission will be granted.

- v) The acceptance of the tender will rest with the accepting authority who does not bind himself to accept the lowest offer or all tenders received and to split up the work without assigning any reasons thereof.

- 11. No **conditional/ incomplete tender** will be accepted under any circumstances.
- 12. THE SUPERINTENDING ENGINEER, MECHANICAL CIRCLE-III, P. H. E. Dte. reserves the right to cancel the N.I.T. due to unavoidable circumstances and no claim in this respect will be entertained.
- During scrutiny, if it comes to the notice of the tender inviting authority that the credential or any other papers submitted are found incorrect / manufactured/fabricated, that tenderer will not be allowed to participate in the tender and that application will be out rightly rejected without any prejudice.

- 15. Qualification Criteria

The Tender Inviting & Accepting Authority through an 'Evaluation Committee' will determine the eligibility of each bidder, the bidders shall have to meet all the minimum criteria regarding:-

- a) Financial Capacity
- b) Technical Capability comprising of personnel & equipment capability (NIT Part-I)
 - c) Experience

The eligibility of a bidder will be ascertained on the basis of the self attested documents in support of the minimum criteria as mentioned in **3(ii)** a,b,c,d,e,f above and the declaration executed through prescribed affidavit in non-judicial stamp paper of appropriate value duly **notarized**. If any document submitted by a bidder is either manufacture or false, in such cases the eligibility of the bidder/tenderer will be rightly rejected at any stage without any prejudice.

16. The tenderer is advised to submit his prices in accordance with the following format only for the equipment, machinery and services offered in Technical part of the offer. The supply portion under Part-A of the BOQ, shall cover cost of materials including freight, handling for providing safe storage. The installation charges under Part-B of the BOQ shall cover supply of all erection materials

including nuts, bolts, washers, gaskets, fasteners, cable glands, cable lugs/sockets, grease, lubricants, wrapping-coating materials etc. and installation of all equipment in its respective position in accordance with the approved drawings, trial run and maintenance.

The installation price shall in no case be less than 10% of the supply price and the commissioning price shall not be less than 2.5% of supply price of equipment. In case of deviation, the purchaser may have the discretion to make the clause 16.0 of Section–I effective. All prices shall be in Indian Rupees and shall be inclusive of all taxes, duties and levies, freight, storage.

INSTRUCTION TO BIDDERS

SECTION - A

1. General guidance for e-Tendering

Instructions/ Guidelines for tenders for electronic submission of the tenders online have been annexed for assisting the contractors to participate in e-Tendering.

2. Registration of Contractor

Any contractor willing to take part in the process of e-Tendering will have to be enrolled & registered with the Government e-Procurement system, through logging on to http://wbtenders.gov.in. The contractor is to click on the link for e-Tendering site as given on the web portal.

3. Digital Signature certificate (DSC)

Each contractor is required to obtain a class-II or Class-III Digital Signature Certificate (DSC) for submission of tenders, from the approved service provider of the National Information's Centre (NIC) on payment of requisite amount details are available at the Web Site stated in Clause 2. DSC is given as a USB e-Token.

4. The contractor can search & download e-NIT & Tender Documents electronically from computer once he logs on to the website mentioned in Clause 2 using the Digital Signature Certificate. This is the only mode of collection of Tender Documents.

5. Participation in more than one work

A prospective bidder shall be allowed to participate for a scheme either in the capacity of individual or as a partner of a firm. If found to have applied severally in a single scheme, all his applications will be rejected for that scheme.

6. Neither prospective bidders nor any of constituent partner had been debarred to participate in tender by the P.H.E. Directorate during the last 5(five) years prior to the date of this NIT. Such debar will be considered as disqualification towards eligibility. (A declaration in this respect has to be furnished by the prospective bidders as per prescribed format without which the Technical Bid shall be treated non-responsive).

7. Submission of Tenders.

General process of submission:

Tenders are to be submitted online through the website stated in Cl. 2 in two folders as per tender schedule, one is Technical BID (Part-I) & the other is Financial BID (Part-II) before the prescribed date & time using the Digital Signature Certificate (DSC). The documents are to be uploaded virus scanned copy duly Digitally Signed. The documents will get encrypted (transformed into non readable formats).

(B) Financial Proposal (Pat-II):

The financial proposal should contain the following documents in one cover (folder) i.e. Bill of quantities (BOQ) the contractor is to quote the rate online through computer in the space marked for quoting rate in the BOQ. Only downloaded copies of the above documents are to be uploaded virus scanned & Digitally Signed by the contractor.

8. Bids shall remain valid for a period not less than **180 (One Hundred Eighty) days** after the dead line date for Financial Bid / Sealed Bid. "Bid valid for a shorter period shall be rejected by the 'Screening Committee' as non-responsive."

9. Opening & evaluation of tender:

9.1 Opening of Technical proposal:-

- i) Technical proposals will be opened by the Superintending Engineer, Mechanical Circle-III, PHE. Dte. or his authorized representative electronically from the web site using their Digital Signature Certificate.
- ii) Intending tenderers may remain present if they so desire.
- Cover (folder) for statutory documents (vide Cl. No. 5.A-1) should be open first & if found in order, cover (Folder) for non-statutory documents (vide Cl. No. -5.A-2) will be opened. If there is any

deficiency in the statutory documents the tender will summarily be rejected.

iv) Decrypted (transformed in to readable formats) documents of the non-statutory cover will be downloaded & handed over to the tender evolution committee.

9.2 Uploading of summary list of technically qualified tenderers:

- i) Pursuant to scrutiny & decision of the *Tender Evaluation committee* the summary list of eligible tenderers will be uploaded in the web portals.
- ii) While evaluation the committee may summon the tenderers & seek clarification / information or additional documents or original hard copy of any of the documents already submitted & if these are not produced within the stipulated time frame, their proposals will be liable for rejection.

9.3 Financial proposal

- i) Financial proposals of the tenderers declared technically eligible by the Tender Evaluation Committee will be opened electronically from the web portal stated in Clause 2 on the prescribed date, by the Superintending Engineer, Mechanical Circle-III, PHE. Dte.
- ii) The encrypted copies will be decrypted and the rates will be read out to the contractors remaining present at that time.
- iii) The Financial Proposal shall be evaluated by the Tender Inviting Authority i.e. the Superintending Engineer, Mechanical Circle-III, PHE Dte, for scrutiny and approval. Final summary result containing inter-alia, name of contractors and the rates quoted by them shall be uploaded provided he is satisfied that the rate obtained is fair and reasonable and there is no scope of further lowering down of rate.
- iv) However, if there is any scope for lowering down of rates in the opinion of the Tender Inviting Authority, further negotiation meeting with the lowest bidder may be held at the office of the concerned Superintending Engineer which will be done offline. The final negotiation statement shall be uploaded in the website.

10. Penalty for suppression / distortion of facts:

If any tenderer fails to produce the original hard copies of the documents (especially Completion Certificates and audited balance sheets), or any other documents on demand of the Tender Evaluation Committee within a specified time frame or if any deviation is detected in the hard copies from the uploaded soft copies or if there is any suppression, the tenderer will be suspended from participating in the tenders on e-Tender platform for a 3 (Three) years. In addition, his user ID will be deactivated and Earnest Money Deposit will stand forfeited. Besides, the P.H.E. Directorate may take appropriate legal action against such defaulting tenderer.

11. Award of contract:

The tender accepting authority reserves the right to accept or reject any Bids and to cancel the Bidding processes and reject all Bids at any time or distribute the work prior to the award of Contract without thereby incurring any liability to the affected Bidder or Bidders or any obligation to inform the affected Bidder or Bidders on the ground for tender accepting authority's action. The Bidder whose Bid has been accepted will be notified by the Tender Inviting & Accepting Authority through acceptance letter. The notification of award will constitute the formation of the Contract. The Agreement in **W.B.F. No. 2911(ii)** will incorporate all agreements between the Tender Accepting Authority and the successful Bidder.
